## THE DISTRICT ATTORNEY WANTS YOU TO BECOME A BETTER DRIVER!

If you are a teenage driver charged with one of the traffic violations listed below, the Safe Driving Program may prevent assessment of insurance points or premium surcharges on your insurance policy and/or points on your **North Carolina** driver's license. This program is made available by the **Wake County** District Attorney's Office and the Safety and Health Council of North Carolina.

**Complete One 4 Hour Defensive Driving Course to Receive a Reduction or a PJC\* Recommendation**

- **NO INSURANCE INCREASE** (if no previous violation or PJC\* in 3 years )

**You are ELIGIBLE for this program if you are 16-21 years old and if your  
Wake County citation is for . . .**

Crossing median - 20-146	Improper passing - 20-150
Cutting across private property to avoid an intersection - 00-000	Improper turn - 20-153

\* A "Prayer for Judgment Continued (PJC)" means the determination of guilt by the court though no sentence has been imposed. With respect to a PJC for any moving violation, there shall be no insurance premium surcharge nor any assessment of points unless the vehicle owner, principal operator, or any licensed operator in the owner's household has a driving record consisting of a PJC for any moving traffic violation during the three years immediately preceding the date of application or the preparation of the renewal. GS 58-36-75(f)

### Class Description

**DDC-Alive at 25** is a unique classroom training program. It speaks directly to young people about the dangers they face while driving—without pulling any punches. Participants are actively involved in frank, open discussions about peer pressure, attitudes, substance abuse, rules of the road, and taking responsibility. Topics include: speeding, following distance, sharing the road with large trucks and other vehicles, cell phone use, and safety belts. All students receive a 28-page course guide and certificate of completion.

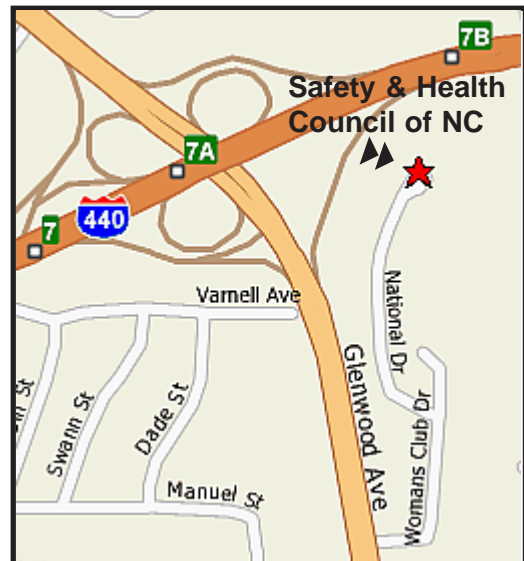

In Raleigh take the I-440 Beltline.

- If you are coming on the Inner Beltline (from Wade Avenue Direction), take Exit 7 and bear right on the exit ramp merging into Glenwood Avenue (going away from Crabtree Valley Mall).
- If you are coming on the Outer Beltline (from the Capital Blvd. Direction), take Exit 7A onto Glenwood Avenue.

On Glenwood Avenue, take a left onto Woman's Club Drive at the traffic light. Woman's Club Drive will become a traffic circle, half way through the circle bear right onto National Drive. Our building is at the end of the cul-de-sac on the right. We're in the Cumberland Building, Suite 201.
