



The District Attorney And Local Law Enforcement Agencies Want You To Be A Safer Driver!

Take A Defensive Driving Course To Have Your Traffic Citation Charges Reduced By The District Attorney...

If you have been charged with a minor traffic violation in the 25th Judicial District, you may elect to have it reduced by the District Attorney, James C. Gaither, Jr., by completing a 4-hour defensive driving course! This course is offered through Caldwell Community College and Technical Institute and the Safety and Health Council of North Carolina to train motorists in the principles of defensive driving. If this course is completed and the information presented in the Clerk of Court's office for payment no later than five (5) working days before your scheduled court date, there will be **No Insurance Points, No Drivers License Points** and **No Court Appearance. Your case will not be Continued!**

You are eligible for this program if your Caldwell County citation is for

In order to take advantage of this opportunity you must:

- 1 Register and complete the four-hour Defensive Driving Course by paying \$50 in cash or money order made payable to CCC&TI.
- 2 Upon completion of the Defensive Driving Course you must provide proof of course completion to the District Attorney's office no later than five (5) working days before your court date. (Example: If your scheduled court date is on a Tuesday, the class must be completed on or before the Wednesday of the week before.)
- 3 Enter into a written Plea Agreement and plead guilty to driving with improper equipment. (The Plea Agreement will be given to you upon successful course completion.)
- 4 Pay court cost of \$150 to Caldwell County Clerk of Court or county in which the ticket was received, upon successful completion. **(No personal checks! Cash or money order only.)**

You are NOT ELIGIBLE for this program if:

- 1 Your charge is not listed on the reverse or your court date has passed.
- 2 You have taken the course in the previous three years.
- 3 You have paid your citation prior to class.
- 4 You have been convicted of a violation carrying 4 points or more.
- 5 You have accumulated 5 points or more in the past three years.

No Exceptions!

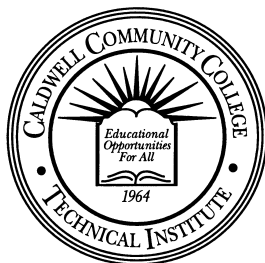
