## The District Attorney & District Court Judges Want You To Be A Safe Driver!

If you have been charged with one of the traffic violations listed above, the Safe Driving Program may prevent assessment of insurance points or premium surcharges on your policy and/or points on your *North Carolina* driver's license. This program is made available by the 29th Judicial District (*Henderson, McDowell, Polk, Rutherford, Transylvania Counties*). To receive these benefits you must complete the 4-hour Defensive Driving Course at least *two* working days before your date.

\*\*If an accident has occurred, points may go on insurance. Check with insurance agency on any questions.

**You are not eligible for this program if:**

1. Your charge is not listed above
2. You have taken the course in the last 3 years
3. You have paid your citation prior to class
4. You have 2 or more moving violations on the same citation
5. You are charged with a violation that requires a court appearance
- 6. You have a commercial drivers license, you are not automatically eligible to attend this course. You must appear in court to request permission to attend a Defensive Driving Course.**
